ADVICE TO THE HOUSELORN

Albany is at her wit's end (Her words, not

mine. She says: What can I paint my steps with that will last longer than one year or less ? I have tried all kinds paint, epoxy, lacquer and even latex and nothing holds up. Last year's marine paint peeled like a bad sunburn in no time at all. I sure wouldn't paint any boat of mine with that stuff at \$79.00 per gallon !!

Mac says: Join the club. I am a member. Due to regulations and environmental concerns, paint is: "NOT WHAT IT USED TO BE" Many of the newer paints are wonderful for certain jobs. Especially for interior jobs. However, the outdoor jobs such as steps, railings, patio furniture and fire escapes, not so much. I am going to try adding some boiled linseed oil to the paint this year and see what happens. I will let you know the results this time next year. If you try it, let me know what results you have.

Rensselaer has a crack problem. Several of the concrete sidewalks around my properties have developed cracks again this year. I have patched them several times with mortar mix and that does not seem to hold up very well. Any suggestions ?

Mac says: Yes, I do. I have had the same problems. Rensselaer and Albany are river banks. They move, settle and in a nutshell they don't stay the same. Also, the freeze/thaw cycle causes cracks. Also, there could be problems that happened when the concrete was poured. Since the mortar did not work, I would clean it all out and try some masonry caulk. It's flexible and the movement of the concrete slabs will be less likely to cause re cracking. Follow the directions carefully, caulking is not mortar. Good luck, the cracks could come back next year in another place. You should however, keep up with the patching since water can get in the cracks, freeze and cause larger cracks.

I have received a lot of questions regarding exterior maintenance. I will try to cover the common ones.

No. 1 question: Gutters. Unless you have the kinds of gutters that prevent clogging by leaves, you will have to check them now. In the winter, leaves get wet and if they freeze they can split your gutters and down spouts. Check for this problem and repair any splits and open seams and repair them. If possible, trim nearby trees and shrubs to minimize this problem. No.2 was masonry steps and sidewalks. We covered the sidewalk problem. If you have precast concrete steps that have pulled away from the building, try to determine if the gap is a hazard or not. Keep an eye on it, if it gets too big, you will have to fill it or try to get the steps back to the building. No.3 Exterior water faucets. Be sure that when you turn on these faucets, that the outside one has not split. If the outside one is too far from the building, have someone there to check that it is not leaking when you turn the inside valve on.

That's it for this month. Remember, I am not the legal eagle, I just do home repairs.
